

This amount, plus the difference, up to 10% of the total contract price, is payable by personal/company checks and credited toward the total contract price. If for any reason the buyer(s) are unable to complete the transaction, the Earnest Money will be forfeited. Final settlement shall be on or before July 28, 2010.

**3. INSPECTION:** Previewing and inspection of is *essential*. The vessel is being sold "AS IS - WHERE IS".

**4. SELLER'S & AUCTIONEER'S DISCLAIMER:** All announcements made by the auctioneer shall take precedence over any previously written material or oral

statements made by auctioneer. Conduct of the auction, increments of the bidding, duration of the auction and decisions as to the high bidder will be at the sole discretion of the auctioneer.
